SKI WARD SKI AREA SNOWTUBING RELEASE AND PROMISE NOT TO SUE

For good and valuable consideration, including permission to use the facilities at Ski Ward, Inc., I agree as follows:

- I. I understand that there are inherent risks related to sports of snow tubing and winter sports activities including but not limited to: variations in snow; steepness and terrain; trailside drop-offs; surface and subsurface snow and/or ice conditions; moguls; rocks; trees and other forms of forest growth or debris (above or below the surface); bare spots; lift towers; cables; utility lines; snowmaking equipment and component parts; and other forms of natural or man-made obstacles and/or trails or chutes, as well as collisions with equipment, obstacles or other skiers, snowboarders, snowtubers or persons. I understand that injuries are a common and ordinary occurrence in snow tubing.
II. To the fullest extent permitted by law I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release and agree to defend and indemnify Ski Ward, Inc. D/B/A Ski Ward Ski Area, its officers, directors, members, agents, representatives, affiliated corporations, shareholders, employees, volunteers, other participants, sponsors, advertisers, promoters, organizers, and owners and lessors' of premises (collectively "the released parties") from any liability, claims, damage or attorneys fees for property damage, bodily injury or death arising out of or in any way connected with my use of the facilities at Ski Ward Ski Area, whether arising from the negligence of the released parties or otherwise. I promise not to bring a claim against or sue the released parties for any property damage, bodily injury or death arising out of or in any way connected with my use of the facilities at Ski Ward Ski Area, whether arising from the negligence of the released parties or otherwise.
III. I further agree that Ski Ward or any person authorized by Ski Ward may use our names, photographs, pictures, slides and movies taken or made by Ski Ward in connection with our use of the facilities at Ski Ward Ski Area, in any manner, for any purpose.
IV. If any part of this agreement is found to be unenforceable, all other parts shall remain in effect and any invalid provision shall be revised so that it is valid.

## **TUBASLIDE RULES AND REGULATIONS**

**Remember these rules are in place to ensure your safety as well as the safety of those around you!**

### **Safety Rules and Regulations**

1. You must be at least six years old and 42” tall to ride TubaSlide;
2. Only **one** person per tube;
3. You must have a valid and visible TubaSlide ticket;
4. You must sit or lay on the tube in such a manner that your legs can drag to act as breaks for slowing down or stopping;
5. We reserve the right to change the start length at any given time;
6. We reserve the right to groom the lanes as conditions warrant;
7. No horseplay on the lift;
8. No linking of tubes on lift and/or on the lanes;
9. No ski boots allowed at any time;
10. You must follow instructions given by lift attendants;
11. When approaching the bottom, drag your foot to slow down and stop; and
12. At bottom, please move out of the way as soon as you stop.
